



the Second Article of our Articles of Incorporation to include under the Corporation's Secondary Purposes the power to guarantee debts, obligations, or loans of a subsidiary or affiliate corporation, and mortgage, pledge, or encumber the properties and assets of the Corporation to secure the obligations of a subsidiary or affiliate.

On June 22, 2023, the Board of Directors clarified and confirmed that the amended provision be as follows: "To guarantee debts, obligations, or loans of a subsidiary corporation, and mortgage, pledge, or encumber the properties and assets of the corporation to secure the obligations of a subsidiary."

The proposed amendment was presented and approved by stockholders at their annual meeting on June 22, 2023. Stockholders owning 3,913,766,695 shares representing 67.68% of the total outsatnding shares approved the amendment.
